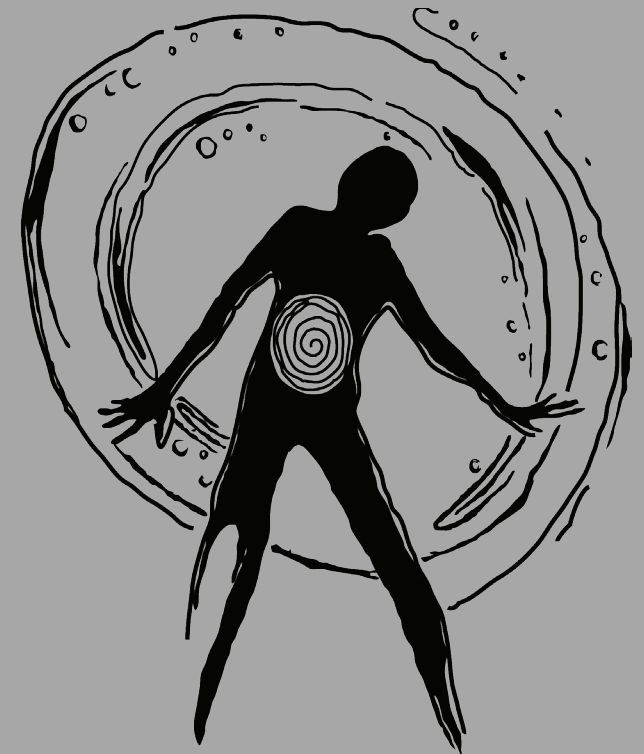

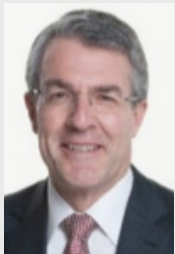
SPEAKERS:



Senator Patrick Dodson Senator for WA, Shadow Assistant Minister for Indigenous Affairs & Aboriginal & Torres Strait Islanders. A Yawuru man from Broome, Senator Dodson's previous roles include Director of the Central and Kimberley Land Councils, Commissioner in the Royal Commission into Aboriginal Deaths in Custody, Inaugural Chair of the Council for Aboriginal Reconciliation and Co-Chair of the Expert Panel for Constitutional Recognition of Indigenous Australians. Recipient of the Sydney Peace Prize.



Alexis Wright is a member of the Waanyi nation, Gulf of Carpentaria. An author and essayist, she has written widely on Indigenous rights and organised two successful Indigenous Constitutional Conventions in Central Australia. Publications include *The Swan Book* (2014 Aust. Lit. Society Gold Medal) and *Carpentaria* (2007 Miles Franklin Award). *What Happens When You Tell Somebody Else's Story* received the 2016 Hilary McPhee Award.

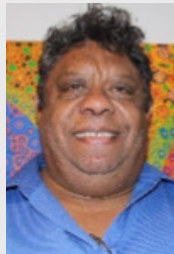


The Hon Mark Dreyfus QC, MP Member for Isaacs, Shadow Attorney General, Shadow Minister for National Security. Elected to Parliament in 2007, Mark studied Arts and Law at the University of Melbourne, has worked with NT Indigenous communities, was involved in the landmark Stolen Generations case and is a leading advocate for retaining Section 18C of the Racial Discrimination Act.

SPEAKERS:



John, Lord Alderdice, by profession a psychoanalytic psychiatrist, was for eleven years Leader of the Alliance Party and one of the negotiators of Northern Ireland's 1998 Good Friday Agreement. The first Speaker of the new Northern Ireland Assembly, he is the recipient of many honorary degrees and awards for his conflict resolution work locally and abroad.



Kenneth Lechleitner Pangarta is a Western Aranda and Anmatjere man fluent in Western Aranda, Anmatjere, Warlpiri and English. He is the Research Officer for the Central Australian Aboriginal Congress (CAAC) and CASSE Aboriginal Men's Shed Research Project, investigating bi-cultural tools for addressing the issues and meeting the needs of Aboriginal men in Central Australia.

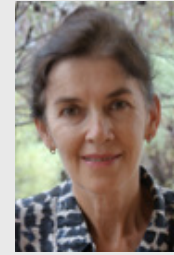


Pamela Nathan is a forensic and clinical psychologist, psychoanalytic psychotherapist and sociologist and is Director of CASSE's Aboriginal Australian Relations Program, working on violence and trauma with Aboriginal organisations and people in Central Australia. She has supervised, researched, developed programs, trained and taught, and published papers and three books as a psychologist and psychotherapist.

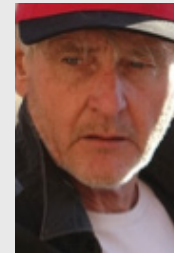
